



**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
UNIVERSITAS BRAWIJAYA, INDONESIA  
AND  
SAMARKAND STATE UNIVERSITY, UZBEKISTAN**

In consideration of the wish of the Universitas Brawijaya, Indonesia and Samarkand State University, Uzbekistan and to establish cooperation within the framework of the academic exchange with the aim of promoting mutual academic cooperation and exchange.

This agreement entered into by and between:

**Universitas Brawijaya** (hereinafter “**UB**”), located at Jl. Veteran, Malang 65145, East Java, Indonesia, is a Public Higher Education Institution established in 1963 represented herein by its Rector, Prof. Dr. Ir. Nuhfil Hanani AR., MS. and shall include its lawful representatives and permitted assigns of the first party.

and

**Samarkand State University** (hereinafter “**SAMDU**”) located at 140104, University blv. 15, Samarkand city, Samarkand region, Uzbekistan, represented herein by its Rector, Prof. Khalmuradov Rustam Ibragimovich and shall include its lawful representatives and permitted assigns of the second party.

**Whereas:** Parties agree to cooperate on academic programs based on equality and reciprocity;

**Whereas:** Pursuant to prevailing laws and regulations in their respective countries, as well as the procedures and policy of the government of Indonesia and the Government of Uzbekistan concerning international collaboration on academic, scientific, and research cooperation;

**Therefore,** in consideration of the above, the Parties have decided to enter into a Memorandum of Understanding (MoU) starting formally from October, 01, 2019.

Parties agree as follows:



## **Article I**

### **Objective**

The objective of the collaboration between UB and SAMDU to promote mutual academic cooperation and exchange between two universities.

## **Article II**

### **Areas of Collaboration**

The two universities will jointly develop some or all of the following activities based on their respective academic and educational needs:

- a) Exchange of faculty members and students;
- b) Exchange of academic literature and information;
- c) Collaborative research;
- d) Post-Doctoral Program
- e) Any other activities to be decided on the basis of mutual agreement by both universities.

## **Article III**

### **Methods of Cooperation**

The implementation of each joint activity set out in this MoU shall be separately negotiated and determined by both universities. Details of the implementation shall be set forth in a contract to be signed at the appropriate time by the level of Faculty, School, Department, Unit or other parties in UB and SAMDU.

## **Article IV**

### **Financial Provision**

The terms and necessary budget for each program and project will be described in separate documents, which will be prepared subsequent into Letters of Agreement (LoA) which will be signed by both parties prior to the initiation of a cooperative program or project. A program may include one or more projects.

## **Article V**

### **Non-Binding Document**

- a) This MoU is not intended to be legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation between the Parties as described above.
- b) Nothing shall diminish the full autonomy of either party nor will any constraints or financial obligations be imposed by either upon the other in carrying out the MoU.

**Article VI**  
**Duration and Termination**

- a) This MoU is written in English and becomes effective upon completion of the signatures, valid for a period of five years from the date of signing.
- b) This MoU is subject to revision or renewal by mutual agreement.

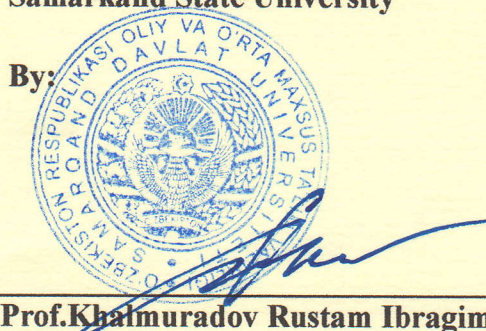
